1. INTRODUCTION TO ANTI-RAGGING Committee:

Anti-Ragging Committee will be the Supervisory and Advisory Committee in preserving a Culture of Ragging Free Environment in the college Campus. The Anti-Ragging Squad-office bearers will work under the Supervision of Anti Ragging Committee and to engage in the works of checking places like Hostels, Buses, Canteens, Class rooms and other places of student congregation. Anti-Ragging Committee will be involved in designing strategies and action plan for curbing the Menace of Ragging in the college by adopting array of activities.

1.1. OBJECTIVES OF Anti-Ragging Committee:

Ragging is a humiliating social crime. The foremost objectives of Anti Ragging Committee are:

- ✦ To absolutely prohibit ragging within or outside the college campus
- ✦ To prevent the occurrence of ragging by following the provisions of Regulations in the institution
- ✦ To provide punishment to those indulging in ragging as provided for in Regulations and the appropriate law in force
- ✦ To sensitize students, to adopt measures that will prevent ragging

1.2. WHAT CONSTITUTES RAGGING: -

Ragging constitutes one or more of any of the following acts:

- ✦ Any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or any other student;
- ✦ Indulging in rowdy or undisciplined activities by any student or students which causes or is likely to cause annoyance, hardship, physical or psychological harm or to raise fear or apprehension thereof in any fresher or any other student;
- ✦ Asking any student to do any act which such student will not in the ordinary course do and which has the effect of causing or generating a sense of shame, or torment or embarrassment so as to adversely affect the physique or psyche of such fresher or any other student;
- ✦ Any act by a senior student that prevents, disrupts or disturbs the regular academic activity of any other student or a fresher;
- ✦ Exploiting the services of a fresher or any other student for completing

- the academic tasks assigned to an individual or a group of students;
- ✦ Any act of financial extortion or forceful expenditure burden put on a fresher or any other student by students;
 - ✦ Any act of physical abuse including all variants of it: sexual abuse, homosexual assaults, stripping, forcing obscene and lewd acts, gestures, causing bodily harm or any other danger to health or person;
 - ✦ Any act or abuse by spoken words, emails, post, public insults which would also include deriving perverted pleasure, vicarious or sadistic thrill from actively or passively participating in the discomfiture to fresher or any other student ;
 - ✦ Any act that affects the mental health and self-confidence of a fresher or any other student with or without an intent to derive a sadistic pleasure or showing off power, authority or superiority by a student over any fresher or any other student

2. ANTI RAGGING PUNISHMENTS/ACTIONS:

2.1 The anti ragging punishment will vary from: -

- ✦ Imprisonment
- ✦ Permanent Expulsion from the institution
- ✦ Suspension from the institution
- ✦ Fine with a public apology
- ✦ Fine
- ✦ Withholding of any form of financial grant (scholarship etc)
- ✦ Withholding of result of examination
- ✦ Debarring from representation in college events

2.2 Powers and Functions: -

- ✦ To uphold and comply with the directions of the Hon'ble Supreme Court and be vigilant on nay acts amounting to ragging;
- ✦ To publicize to all students and prevalent directives and the actions that can be taken against those indulging in ragging;
- ✦ To consider the complaints received from the students and conduct enquiry and submit report to the Anti- Ragging Committee along with punishment recommended for the offenders;

- ✚Oversee the procedure of obtaining undertaking from the students in accordance with the provisions;
- ✚Conduct workshops against ragging menace and orient the students;
- ✚To provide students the information pertaining to contact address and telephone numbers of the person(s) identified to receive complaints/distress calls;
- ✚To offer services of counseling and create awareness to the students;
- ✚To take all the necessary measures for prevention of Ragging on the Campus/ Hostels.

4. ANTI RAGGING SQUAD

4.1 FORMATION

Mobile squad shall be formed from time to time to facilitate up keeping and upholding the objectives of the cell. The cell so formed shall be with the approval of the chairman and known only to ARC.

4.2 ROLES

The Anti-ragging squad is formed for overseeing the implementation of the recommendations of the anti-ragging committee.

- ✚ The Anti-Ragging Squad shall be maintaining vigil, over sight and patrolling functions and shall remain mobile, alert and active at all times on the campus.
- ✚ In any case of ragging sighted, the situation shall be secured, reported to the Anti-Ragging Committee for further course of actions.

5. ANTI RAGGING AFFIDAVIT:

An anti-ragging affidavit is a declaration made by students and their parents to ensure that they understand the implications of ragging and agree to abide by the rules and regulations set by the institution to prevent it. The students are compulsorily instructed to fill this affidavit on:

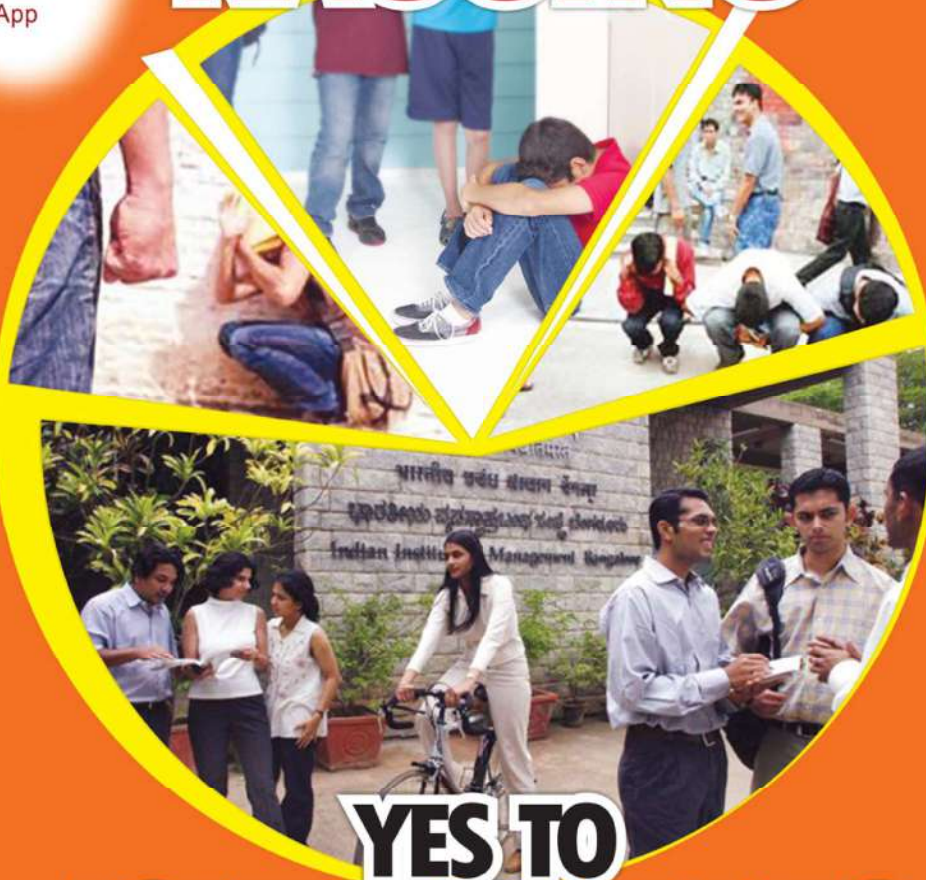

Any Act Resulting in:

- Verbal Abuse
- Indecent Behaviour
- Criminal Intimidation/wrongful Restraint
- Undermining Human Dignity
- Financial Exploitation/extortion
- Use Of Force

A STUDENT INDULGING IN RAGGING CAN BE:

- Cancellation of admission.
- Suspension from attending classes.
- Withholding/withdrawing Scholarship/Fellowship and other benefits.
- Debarring from appearing in any test/ examination or other evaluation process.
- Withholding results.
- Debarring from representing the institution in any regional, national or international meet, tournament or youth festival etc.
- **Collective punishment** : when the persons committing or abetting the crime of ragging are not identified the institution shall resort to collective punishment as a deterrent to ensure community pressure on potential ragger.

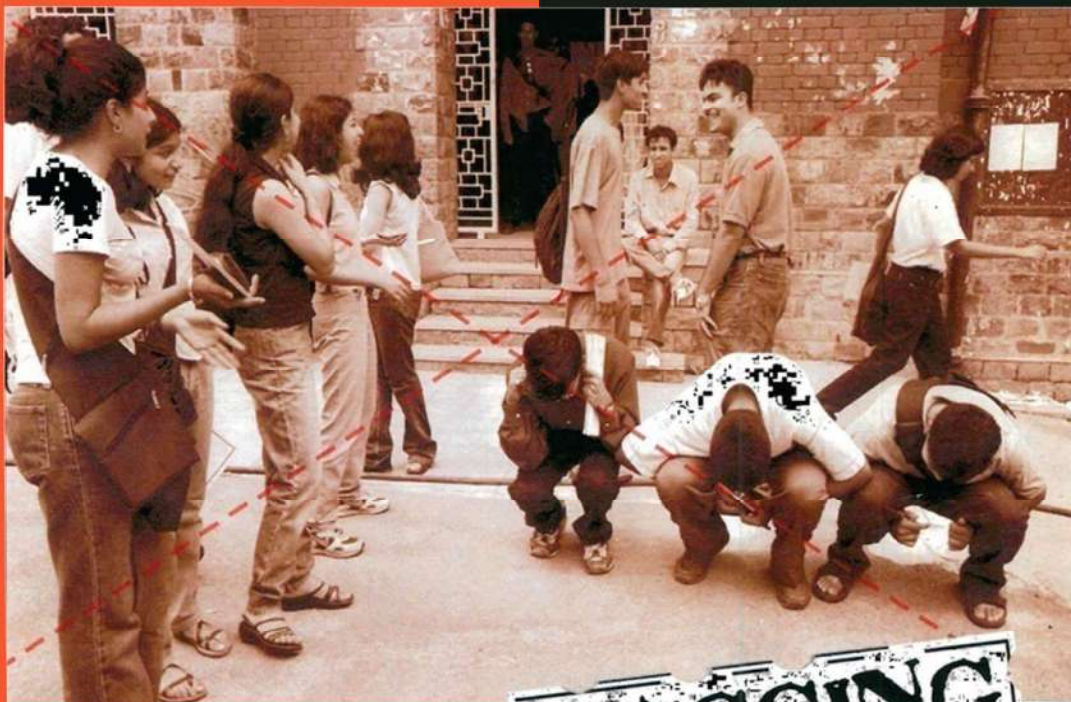
