MEMORANDUM OF UNDERSTANDING

AND

MAHILA SARVANGEEN UTKARSH MANDAL (MASUM) PUNE, MAHARASHTRA the second Party, and represented herein by its FOUNDER AND CO- CONVENER DR. RAMESH AWASTHI (herein after referred to as "Second Party", NGO which expression, unless excluded by or repugnant to the subject or context shall include its successors – in-office, administrators and assigns).

(First Party and Second Party are hereinafter jointly referred to as 'Parties' and individually as 'Party') as

WHEREAS:

A) First Party is a Higher Educational Institution named:

(i) WAGHIRE COLLEGE OF ARTS, COMMERCE AND SCIENCE, SASWAD

B) First Party & Second Party believe that collaboration and co-operation between themselves will promote more effective use of each of their resources, and provide each of them with enhanced opportunities.

C) The Parties intend to cooperate and focus their efforts on cooperation within area of Skill Based Training, Education, career guidance and students counseling.

D) Both Parties, being legal entities in themselves desire to sign this MOU for advancing their mutual interests.

E) MAHILA SARVANGEEN UTKARSH MANDAL (MASUM) PUNE, MAHARASHTRA-, the Second Party is engaged in social work activity, in Purandar Taluka area as well as all over in Maharashtra and India and also on international level. MASUM's focus evolved out of a commitment to women's rights within and outside the home, working with a feminist perspective and human right approach. MASUM's primary belief is that people can resolve their own problems collectively with some amount of

external support; this rather than create dependence on itself, MASTUM focused on strengthening people's perspectives on democracy, equality, secularism and social justice

F) MAHILA SARVANGEEN UTKARSH MANDAL (MASUM) the Second Party is promoted by MAHILA SARVANGEEN UTKARSH MANDAL (MASUM) 42, KUBERA YHAR, CABBITAL, HADPSAR, PUNE- 411028 (Ph.) - 020- 26995625/3 (website) www.masumi-india.org/in

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERE TO AGREE AS FOLLOWS:

CLAUSE 1 CO-OPERATION

1.1 Both Parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations within the Institution and its related wings. The Parties shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for one another.

1.2 First Party and Second Party co-operation will facilitate effective utilization of the intellectual capabilities of the faculty of First Party providing significant inputs to them in developing suitable teaching / training systems, keeping in mind the needs of the each other.

1.3 The general terms of co-operation shall be governed by this MOU. The Parties shall cooperate with each other and shall, as promptly as is reasonably practical, enter into all relevant agreements, deeds and documents (the 'Definitive Documents') as may be required to give effect to the actions contemplated in terms of this MOU. The term of Definitive Documents shall be mutually decided between the Parties. Along with the Definitive Documents, this MOU shall represent the entire understanding as to the subject matter hereof and shall supersede any prior understanding between the Parties on the subject matter hereof.

CLAUSE 2 SCOPE OF THE MOU

2.1 Both parties believe that close co-operation between the two would be of major benefit to the student community to enhance their skills and knowledge.

2.2 **Training & Visits:** MAHILA SARVANGEEN UTKARSH MANDAL (MASUM) and Institution interaction will give an insight in to the latest development of students skill and knowledge; the second Party to permit the Faculty and students of the First Party to visit its office place for getting help which is possible for second party and also involve in Training program for First Party. MASUM's training and exposure provided to students and faculty through this association will build confidence, personality development and prepare the students to face challenges of daily life, career counseling, and also provide the skill and knowledge for contribution in development of society on basis of equality and social justice.

2.3 **Skill Development Programs:** Second Party to train the students of First Party on Peer counseling skill, career guidance and personality developments.

2.4 **Guest Lectures:** Second Party to extend the necessary support to deliver guest lectures to the students of the First Party on Stress management, mental health, Peer counseling, Nonviolence, Democracy, Gender, Equality and also on topics related to youth issues.

2.5 **Faculty Development Programs:** Second Party to provide training to the Faculties of First Party for imparting training to enhance capacity of faculty and also for making teaching learning process effective and happy, if available.

2.6 Both Parties to obtain all internal approvals, consents, and permissions, of whatsoever nature required for organize program and training on the terms specified herein as per their term and condition.

2.7 There is no financial commitment on the part of the **WAGHIRE COLLEGE OF ARTS, COMMERCE AND SCIENCE, SASWAD**, and the First Party to take up any programme mentioned in the MOU. If there is any financial consideration, it will be dealt separately.

CLAUSE 3 INTELLECTUAL PROPERTY

3.1 Nothing contained in this MOU shall, by express grant, implication, Estoppels or otherwise, create in either Party any right, title, interest, or license in or to the intellectual property (including but not limited to know-how, inventions, patents, copy rights and designs) of the other Party.

CLAUSE 4 VALIDITY

4.1 This Agreement will be valid until it is expressly terminated by either Party on mutually agreed terms. MASUM's training and exposure provided to students and faculty through this association will build confidence, personality development and prepare the students to face daily life challenges, career counseling, and also provide the skill and knowledge for self-development as well as for student's contribution in creating society on basis of equality and social justice. **MAHILA SARVANGEEN UTKARSH MANDAL (MASUM)** the Second Party, as the case may be, will take effective steps for implementation of this MOU. Any act on the part of **MAHILA SARVANGEEN UTKARSH MANDAL (MASUM)**, the Second Party after termination of this Agreement by way of communication, correspondence etc., shall not be construed as an extension of this MOU.

4.2 Both Parties may terminate this MOU upon 30 calendar days' notice in writing. In the event of Termination, both parties have to discharge their obligations

CLAUSE 5 RELATIONSHIP BETWEEN THE PARTIES





